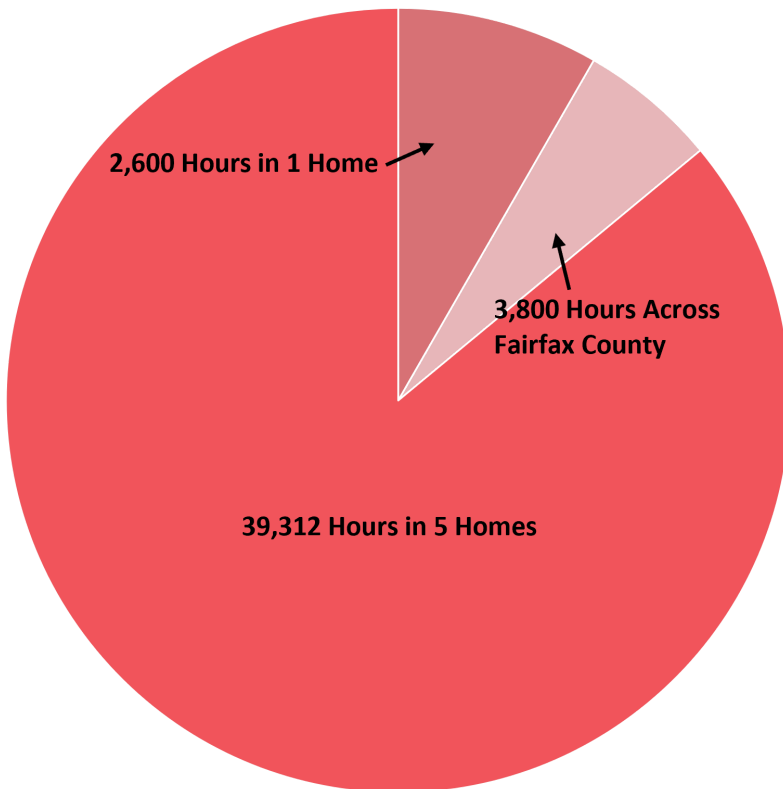

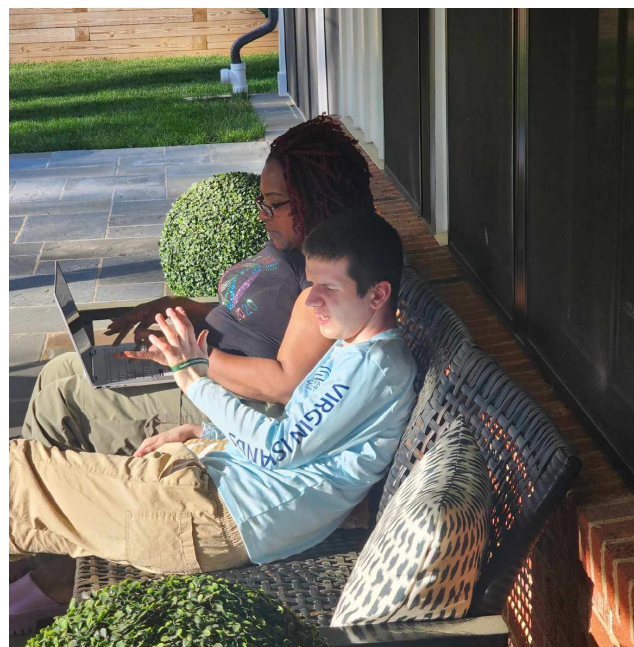




WELCOME HOME

Last June, the doors to our sixth group home, the Atwood House, opened. After years of careful planning, preparation, and dreaming, we welcomed three new residents in 2024 and have added a fourth resident in early 2025.

The dream of Atwood and a life of independence was something the Marsh family had always hoped for their son, who moved in that summer. Since moving into the home in 2024, the residents have all honed essential daily living skills, such as cooking, and developed vital community access skills, including forming lasting friendships with one another.

It's a beautiful home with beautiful people who have big hearts, looking after and caring for the young men.
